Arts Education

On December 8, The Arts Now: LA County Arts Education Summit marked 15 years of coordinated efforts in arts education for the County, and was co-presented by the LA County Arts Ed Collective, the California Alliance for Arts Education, Arts for LA and the Los Angeles County Arts Commission. Two hundred arts educators, school district administrators, funders and community arts partners convened at the Japanese American National Museum. The event was part of the statewide Arts Now Campaign, which works to shed light on school districts and counties that are currently working to improve the quality of student education through the arts, and to encourage others to prioritize arts education in a K-12 educational setting. Speakers included Ann Burroughs, President and CEO; Japanese American National Museum, Genethia Hudley Hayes, education deputies for Supervisor Sheila Kuehl, Third District, Alex Johnson, President, LA County Board of Education; Supervisor Hilda Solis, First District and Denise Grande, Director of Arts Education at the LA County Arts Commission. Super visor Solis presented an honorary scroll to The Arts Ed Collective and California Alliance for Arts Education for continued leadership and dedication to arts education in the region. The celebration also featured student's art work, performing jazz music and dance.

Artesia Library Dedication

The community of Artesia celebrated the dedication of their new library and the site specific artwork, Lady Artesia, by artist Sonia Romero who was presented a scroll by Supervisor Janice Hahn. Reflecting the diversity of the Artesia community and the important contribution of water in the development of the city, the artwork depicts a compressed, multilayered visual timeline of the city's past, present and future. The ceramic tile composition features a blue and white vignettes of people surrounding a central female figure meant to embody Artesian well water—the primary natural resource for early Artesian farming and dairy settlers. Influenced by Portuguese and Spanish Azulejo tile, Mexican Talevera tile, and Chinese and Middle Eastern porcelain wares, Ms. Romero chose the reoccurring blue and white ceramic color composition to represent the city's intense diversity and to highlight Dutch and Portuguese farmers who settled Artesia and the surrounding areas into flourishing dairy districts.

MLK East Parking Structure Artwork Fabrication Site Visit


The Martin Luther King Jr. East Parking Structure project team visited the Carlson Arts workshop to see artist Rob Ley's sculpture in fabrication. This large scale artwork measures approximately 32'x102'x2' and will cover three floors of the structure's front façade facing Wilmington Avenue. The artwork consists of 22 panels covered with over 2,800 aluminum fins in varying angles and sizes.

Part of the Solution: YES to ADU Workshop with SCANPH at CDC

In collaboration with the Community Development Commission (CDC) and the Southern California Association of Nonprofit Housing (SCANPH), the Civic Art team held a public workshop at CDC to provide background information and discuss guidelines for the *Part of the Solution: YES to ADU* design competition. Grants and Professional Development

Community Impact Arts Grant

The 2018 Community Impact Arts Grant (CIAG) program received 59 applications. These applications were reviewed in four grant review panels comprised of artists, arts and nonprofit professionals and community stakeholders in early December. Panel presentations to the Arts Commissioner's will take place in January 2018.

Organizational Grant Program

There were 244 applications received for the 2018-19 Organizational Grant Program. Sixteen grant review panels comprised of artists, arts administrators and community stakeholders are being assembled to review and score OGP applications during the months of January through March 2018.

On December 9, the Arts Commission held an Arts Tune-Up at the Ken Miller Recreation Center in Torrance. Approximately 50 artists and arts administrators attended. Topics included Budgeting Basics, Grant writing Strategies for Emerging Nonprofits, Equity and Inclusion, and Creative Conflict Resolution.
