# **Update from the Acting Executive Director**

LA County's commitment to the arts and culture sector, as demonstrated by the work of the Arts Commission, has resulted in a well-established reputation across the country. The work is viewed as innovative and forward-thinking, and is developed and implemented by individuals regarded as thought leaders in the field.

It is through this lens that the Arts Commission staff proudly represents the County at critical gatherings, convening's and conferences, covering a range of topics, from equity and inclusion, to professional development and research.

## **Arts Education**

The LA County Arts Education Collective and LA County Office of Education co-hosted "Teaching Creativity: Integrating the Arts into Common Core English/Language Arts," elementary school principals, assistant superintendents and curriculum leaders convened at The Huntington Library, the workshop framed the importance of arts education around California's adoption of Common Core state standards and changes to student assessment. This is the first of two workshops in a two-part series sessions which will happen throughout the year.

The LA County Arts Education Collective hosted the Arts Education in the North County: A Cross-sector Conversation, at the City of Santa Clarita. School district leaders, community arts education partners from Antelope and Santa Clarita Valleys, participated and shared viewpoints and exchange strategies for achieving equity in arts education in the northern region of the County. They establish and deepen cross-sector partnerships and identify opportunities to link K-12 arts education to college and career pathways in creative industries.



# Civic Art

#### **Los Nietos Library Opening**

The Los Nietos Library opened this month with a dedication featuring Supervisor Janice Hahn who presented artist Louise Griffin with a scroll acknowledging her contribution, a 3-dimensional mural on the façade of the library, entitled\_Reflections on the Past, Present & Future of Los Nietos. The mural was inspired by conversations with community members, who shared with the artist their strong connection to the middle school property, which is located on the same grounds as the library. The mural's cascade of leaves represents the beloved old tree that stands in front of the school's entrance and the tree itself symbolizes the deep roots of the community. As the artwork wraps around the corner of the meeting room wall towards the main entrance, it transitions into colorful panels with historical imagery collected from community members, creating a timeline documenting the area's rich history while

#### **Professional Development**

Civic Art staff participated in a number of professional development opportunities this month including "The Future History of Public Art Symposium" which brought together administrators, directors, artists, critics, curators, academics and researchers to consider the future of the public art field; the Common Field Convening, bringing together a network of experimental, contemporary artist-run and artist-centered organizations. A number of commissioned civic art artists and organizations the Arts Commission has partnered with participated; the convening of the Museum Computer Network (MCN), a gathering of arts administrators working with digital media to further their respective institutions' missions and engage audiences with technology.



# **Grants and Professional Development**

#### **Organizational Grant Program**

November 1 marked the final application deadline for the OGP 2018-19 funding cycle. A total of 244 applications were submitted this year, 23 more than the last cycle. Applications submitted by new applicants totaled 34. The number of OGP applications received during October and November was as follows:

- OGP 4 (budgets greater than \$15,000,000) 4 applicants
- OGP 3 (budgets between \$1,000,000 and \$14,999,999) 35 applicants
- OGP 2 (budgets between \$200,000 and \$999,999) 75 applicants
- OGP 1 (budgets under \$199,999) 130 applicants
